## Regulations & Requirements

- Property owners have the right to protect their property and have access to the water
- State tidal wetlands begin at the Mean High Water (MHW) line
- Landward of the MHW is the Critical Area (1000 ft)
- First step is to call MDE for a pre-application meeting:
  - o Mary Phipps-Dickerson, 410.901.4033
  - If possible include Army Corps of Engineers, Critical Areas Commission (DNR), and your contractor at the meeting
  - Shoreline Stabilization Fee is waived with living shorelines projects, unless you plan to do additional structural work
- Living Shoreline should be maintained at least 3-5 years and with 85% of vegetative cover maintained.
- Maintenance includes removing debris, replanting bare spots, limiting lawn fertilizer, and no mowing.
